## COOKIE POLICY

This policy, together with the Privacy Policy, sets out certain management rules on our website [International Food](#), also regarding the use of user's information.

This policy is provided and only applies for this website and not for other sites, which can be accessed by the user through links on the site. **International Food** is not responsible for these sites nor for the procedures they apply to respect data confidentiality, therefore, **International Food** would recommend to read the privacy policies of all parties you come into contact with, before disclosing any personal information.

In particular, this section provides information about the cookies active on the website and how they are used. The Cookie Policy (or "Extended information on the use of cookies") set out below, regarding the use of cookies on the website, is provided in implementation of the Provision of the Guarantor for the protection of personal data, the "Identification of simplified procedures for the provision of information and the acquisition of consent for the use of cookies", or in compliance with further clarifications and guidelines issued by the same Authority, national legislation and competent European Authorities.

### DATA CONTROLLER

### WHAT ARE COOKIES

A "cookie" is a small text file installed by certain websites on your computer in the moment you access a particular site or use certain services provided by the site. The purpose is to store and transmit information. Cookies are sent from a web server (which is the computer running the site you are visiting) to your browser (Internet Explorer, Mozilla Firefox, Google Chrome, etc.) and stored on your device. ### WHAT THEY ARE USED FOR

In general, cookies can be used for a number of reasons, for example to monitor how visitors use the site, to improve page navigation, to allow you to set personal preferences on the sites you are visiting, to protect your security, to provide ads based on your interests.

### TYPE OF COOKIES AND PURPOSES

In general, according to common terminology, cookies can have different characteristics that allow them to be classified according to:

- permanence on the user's device: in this case we can talk about session/temporary cookies or persistent cookies;
- origin: in this case we can talk about first-party cookies (sent to your browser directly from the site you are visiting) or third-party cookies (sent to your browser from other sites and not the one you are visiting);
- purpose: in this case, also according to the provisions of the Italian Data Protection Authority, we can talk about technical cookies or identifying and profiling analytical cookies.

According to this classification, the same cookie could also have all these characteristics together, being, for example, a persistent cookie, originating from a third party and with profiling purposes.



## TIME OF PERMANENCE

*Session/temporary cookies:* they are not stored persistently but only limited to the duration of the browsing session. This means that they are automatically deleted from the user's device, once the user has left the website and closed the browser.

*Persistent cookies:* they are stored on the user's device until they are deleted by the user or until they reach their expiry date if pre-set. This means that they are not automatically deleted from the user's device, once the user has left the website.

## ORIGIN

*First-party cookies:* these are cookies issued by the website visited at the time; the website is the one corresponding to the address entered by the user (the website displayed in the URL window).

*Third-party cookies:* these are cookies issued by a website other than the one visited by the user.

## PURPOSES

*Technical cookies:* these cookies are essential in order to navigate the site and use specific functionalities. They can be classified in:

- *Navigation/communication/performance cookies:* they ensure normal navigation and use of the website (i.e. allowing you to make a purchase or authenticate yourself to access reserved areas); if these cookies are blocked, the website may no longer function properly.
- *"Strictly necessary" cookies (functionality/preferences/localization/session status):* they allow you to store information that changes the behaviour or the appearance of the site (preferred language, text and font size, geographical area you are in). If they are blocked, the browsing experience will be slightly less functional but not compromised. These cookies allow the site to memorize the choices you make (such as language preference, what content you are interested in, etc.) and to provide the personalized features you select, in order to improve your browsing experience. In some cases, these cookies may also be used to provide online services (i.e., the provision of a live chat service) or to prevent offering services that user has refused in the past.

*Analytical cookies:* Analytical cookies are used to allow web services to collect information relating to user's access, for example, the number of visitors, the permanence in the site and which parts of the site they visit. They could be first- or third-party cookies.

- *Statistical/analytics third-party cookies without identification purposes (with IP masking and no cross-referencing with other data held by the third party):* these cookies can be assimilated, according to the current legislation, to technical cookies, as they meet the following conditions: adoption of measures that reduce the identifying power of the cookies by masking portions of the IP; the third party refers to the commitment to use these cookies exclusively for the provision of the service, and to store them separately and not to "enrich" them or "cross-reference" them with other available information.
- *Third-party statistical/analytics cookies with identification purposes:* these are cookies used to collect information and generate website usage statistics, to understand how visitors interact with the site. These cookies are considered to have high identification value when *are not in place*, at the same time, the following conditions: (i) no features are implemented to reduce the identifying power of the cookies (i.e. by masking significant portions of the IP); (ii) the third party cross-references the information contained in the cookies with other information already in its possession.

## WHAT COOKIES WE USE AND HOW TO MANAGE OR DELETE COOKIES

This website uses different types of cookies and related technologies, each of which has a specific function. The site can be navigated by users even without the use of cookies but the navigation may not be the best possible. The cookies used and their function are listed below.

*Browsing and session cookies*

Navigation and session cookies ensure the normal navigation and use of the website. Browsing cookies are technical cookies and, therefore, they are necessary for the operation of the site and to improve quality and experience. Necessary cookies contribute to the usability of the website by enabling basic functionalities such as navigation through the pages and access to secure areas of the website. The website cannot function properly without these cookies.
